State political wrap-up to date: Once again, my thanks to those of you who made phone calls, sent FAXes and e-mails in recent months, particularly prior to the state's application for RTTT (Race to the Top) funds and the prolonged discussion of charter schools. With our help, the Governor's proposal regarding charter schools did not go through. It is difficult to assess why a relatively few legislators favored raising the cap on the number of NYS charter schools to more than double the current number. As you have read in the NEW YORK TEACHER,

NYSUT's position would require that charter schools serve the same population as regular public schools (including English language learners and students with disabilities), that their operators disclose how and where they spend taxpayer dollars, where other support comes from, and who is enriched by their operation. "Kids must come before corporate profits." These fairness, transparency and accountability measures were not addressed in the Governor's proposal. There will be a second round of RTTT applications in June, so this topic is not dead. Stay tuned - and actively involved.

We now have the Governor's Budget before us, with a proposal to slash \$2.7 billion from education and health care. Funding for Teacher Centers would be eliminated, operating aid to classrooms, educators and programs cut; SUNY/CUNY would lose \$181.6 million - and so on. These are among the agenda items that will be discussed with our legislators at the March 16th Committee of 100 meeting in Albany.

Locally, school districts feel the pain. Port teachers do not yet have a contract, with negotiations now ongoing since last spring. The district is making every effort to bring in a low budget which they hope the community will support - but as we all know, keeping our high academic standards should preclude cutting programs and staff. We must all support a budget which will maintain the quality and integrity of our Port Washington educational system. The community whose education goes downhill takes a nosedive in every other direction as well. It is trite but oh so true - kids are our future and our hope.



Despite the announcement last fall by school board president, Karen Sloan, that an agreement with the teachers on a successor agreement to the contract (which ended on June 30) was imminent, negotiations have not yet been concluded. In solidarity with our colleagues who work so diligently to teach the youth of our community, we wish them an early and successful conclusion to this long drawn-out process.

VOLUNTEERS NEEDED FOR MODEL BOAT REGATTA

After my years at Weber, one of the things that is making my time fun is volunteering in the classroom with third graders and the Model Boat Regatta. I started as a classroom volunteer and now I am one of the organizers. I enjoy all of this and am wondering if any of my fellow retirees would like to share in this satisfying experience.

Every year during HarborFest in Port Washington, there is a model sail boat race on one of the Port Ponds. As some of you may know, these sail boats are made by Port Washington third graders out of recycled juice cartons collected by the students with additional parts supplied by the Chamber of Commerce. We are looking for additional volunteers to go into each classroom and teach the children how to make the boats. It takes two one-hour sessions with each class to complete the boats and discuss what makes a boat "go." The schools will schedule their class sessions Tuesdays through Fridays starting Tuesday May 4 through Friday June 4, 2010. The culmination of this activity is the Model Boat Resatta on Sunday, June 6, 2010.

All new volunteers will be trained on how to build the boats during one of two evening training/refresher meetings scheduled at the end of April and new volunteers will be paired with experienced volunteers. Most volunteers sign up for at least 4 sessions, all on one day or two sessions for two days. The teachers and the students all really enjoy this activity and it is a lot of fun for the volunteers.

A Tsunami Refugee, February 27, 2010

While I've always been aware of the danger of tsunamis here in Hawai'i, (I had even packed an emergency kit with clothes, that would never fit now, years ago.) I'd never had to evacuate my home before. Yes, there's always a first time for everything! Like everyone here who lives near the water. I left home at 9 a.m. as directed by the police loudspeaker on the patrol car that came down our street at 8 a.m., Since the center of this island is a chain of mountains, Kohala, Mauna Kea, Mauna Loa and the Hualalai Mountains, it's a short drive to higher ground.



Hawai'i's past experience with tsunami devastation and the state's distance from immediate help, including from its own neighboring islands, has made it possibly the best prepared state in the nation to handle disasters. The island of Hawaii, even more than the others, is constantly on the alert because it experiences

frequent earthquakes that can generate tsunamis and it's the first to feel the effects from a tsunami caused by an earthquake near the coasts of North or South America. Our phone books outline emergency procedures and evacuation routes (Art Mittelstaedt was so impressed with our phone book evacuation and preparedness directions that he copied them for future reference in his work, and our Civil Defense is quick to break into radio and TV programs with emergency warnings and instructions. Between the TV, the radio and all those sirens wailing near every inhabited area, not to mention the many phone calls from friends and family here and on the mainland, it is hard not to know what is happening. We were luckier here in Hawaii, after the Chilean earthquake, than the islands closer to that country. Not only do we have 24 hour a day worldwide earthquake surveillance personnel on duty both on this island and on Oahu, but we had more than 12 hours to prepare. In addition, our statewide Civil Defense system had run a practice tsunami evacuation drill for emergency personnel just six months before. While the lack of a high wave was disappointing to many anxiously anticipating seeing one, our surrounding ocean was extremely "restless" for most of the following week. This exercise, however, prioritized for me the need to be prepared at all times. The next time, and there will be one with the increasing frequency of powerful earthquakes occurring worldwide these days, there may not be this much of a warning. The next time might not even be caused by an approaching tsunami but a fire or some other emergency. These days, I don't let my car's gas tank go below half full and I keep all important documents together where they are safe but can be grabbed in one hand as I rush to leave. Your Editor, Jean

At Martha Puglia's retirement party, then Superintendent Bill Heebink presented her with a -shirt that proclaimed, "There's No Day Like a Snow Day." In-service or retired, it's still thrilling to have an unexpected day of "stolen kisses," when nothing's planned, and spending a whole day in PJ's comes guilt free.

A blue and white tablecloth represents the ideal snow day for me.

I was lucky to have a second mother, whom I called Aunt Helen, a neighbor who couldn't have children, in whose apartment I was always welcome. She was of Czech descent, and snow, for her, meant making strudel. Not buying the phyllo dough at the store, but mixing it from scratch, and pounding it on the table I'd guess about 100 times till it was just right. (Compare the counter space in our tiny Bronx apartments which amounted to the drain board next to the sink, with the seeming acres of counter space we have today.)

Next she'd stretch the dough, on that blue and white cloth, until it was so thin that the white pattern of flowers and leaves showed through it. Then the apples she'd sliced, sweetened and mixed with cinnamon, raisins and bread crumbs fried in butter, were spread on the dough, and rolled up. Baked heaven. My Aunt Helen was not only a great, adventurous baker, but she knew how to share.

My mother was a wonderful cook, but everything she baked, cakes, bread, muffins, came out a cookie. This might have been because the real oven in my house was filled with paper grocery bags that she would reuse, and so she baked everything in a top of the stove oven, a primitive-seeming boxlike device that sat on a burner. This worked great for potatoes, or chicken. In fact, the night of a black out, she created what we ever after called black out chicken—cooking it in the dark in that oven. We also had a Roto Broil 400, a portable electric oven. One summer day, she put the hot broiler tray on the table, and, while wearing shorts, walked into the edge of it. She got a rectangular burn on her thigh from where the handle would go, and my dad claimed he'd branded her.

Interesting how food binds families and memories. When my great nieces and nephew visited from way out in the country in Caldwell, Texas, where there are no baked goods for sale as we know them, a great day on their visit to Port meant going from bakery to bakery, sampling the wares of each. Our family album has photos of Simon with a big smile and bag posed in front of each place (including Let There be Bagels where he ate his first bialy—heaven for him).

Too bad I don't have photos of my kitchen muses, my mom and my Aunt Helen, at work in their domains. But their creations, the smell, the taste, and their devising, are vivid-- and traces probably live on somewhere in my body, as well as in my memory.

'COUNSELOR' TAKES THE MYSTERY OUT OF MEDICARE

Anyone who's ever tried to decipher Medicare knows it can be like reading a road map upside down. NYSUT retired members who need help turning that map right-side up can get it through the Medicare Rights Center's Medicare Interactive Counselor. The Medicare Interactive Counselor is an online resource that provides information and answers some of the most frequently asked questions about Medicare.

For NYSUT members, a special version of Medicare Interactive Courselor is available at www.nedicareinteractive.org/ teachers. Or, go to the NYSUT Web site — www.nvsut.org — click on the link on the left for "Retirees and retirement," and from there, click on the Medicare Interactive icon on the right side.

NYSUT retired members who go to the dedicated site for teachers will find information specific to New York state. Once at this site, retirees will see an array of topics they can read about further.

"We know that people sometimes find Medicare issues so complex that they are reluctant to ask questions," said former NY-SUT Executive Vice President Alan Lubin, who is a board member of the Medicare Rights Center.

"The beauty of this interactive feature is that people can look up an answer on their own. It's a very comfortable, user-friendly way to familiarize yourself with this complex topic."

Retirees who haven't been able to answer their questions can call the Medicare Rights Center hotline at 800-333-4114 to speak with a trained and knowledgeable person.

The Medicare Interactive Counselor offers users three ways to seek information: By reading "most frequently asked questions" and the answers; by selecting a topic from a list of choices; and by a general search using a keyword.

"The Medicare Interactive Counselor is a wonderful way for retired members to take charge of a challenging subject and come out much better informed," said Kathleen Donahue, NYSUTs vice president who oversees retirement services. "We hope that NYSUT retired members will make good use of this terrific resource."
