Who or What is ALEC????

Perhaps you have heard by now of ALEC - the American Exchange Legislative Council. This is a nation-wide group seeking to influence state legislatures on such matters as taxes, workers' rights, pensions, gun control, air and water quality etc. At its annual convention of some 300 corporate and 2000 state representatives task forces were chosen to draw up "model" legislation to be introduced to state legislatures. Legislators then introduce Bills as their own, with no reference to ALEC. Corporate participants (e.g. Exxon-Mobil, Wal-Mart, UPS, AT&T, Koch Industries, Verizon etc.) pay tax deductible membership fees of \$7000-25,000 and state legislators pay \$100. Claiming not to be lobbyists, ALEC is instead a 501(c)3 tax exempt organization "educating" members and therefore not subject to lobbying laws and regulations. They claim responsibility for writing 1000 Bills per year and having 200 pass in state Houses. Corporate access to and manipulation of legislative goings-on of American democracy? **You betcha!**

Think of the Lion the Witch and the Wardrobe and the back of the closet; of Alice and Wonderland and the looking glass; of Harry Potter and the seemingly impermeable brick wall entrance to the train track to Hogwarts—all have in common the magical entry through a portal, which opens for admission to an otherworldly place.

Nowadays, there is another kind of portal, a medical one, but not so magical, and for me, not so magically easy to enter and use. Meant as a storage place to easily access all of a patient's medical records, this portal for the rest of us is meant to unify a patient's information, to provide access to the "total person" both for the patients and doctors. Interestingly, I have been "invited" by medical groups affiliated with two different hospitals to join each hospital's portal, thus seemingly defeating the purpose of providing access to everything in one place. Additionally, now asking for a copy of the test I have just taken now elicits this response: "You can easily access your information on our portal."

Whoa, maybe not quite so easily! To access the portal, an account has to be set up which includes the answer to a security question. How many of you remember the month, day and year you graduated from High School? Your best friend's birthday? Your parents' birth dates? I had to consult with a person over this—and found myself explaining at length that I graduated 51 (!!) years ago, in January some time; that my parents birthdays are in the same month and I always mixed them up; and that two of my best friends have been gone for about 14 years or so. I am finally able to find something to use, finish the process, and then attempt to use the portal to obtain my most recent blood test results to add to my records, as I have been tracking them over the years.

Proudly I enter the portal!! Snafu #1 emerges: Since I cancelled and have not yet reinstated my fax number, nor have I gotten a new printer linked to my computer yet, I request that a copy be sent to me by (gasp!) *mail*. Surprise! First I have to be sent a HIPPA form to get my own results!! Mailed, of course, and then mailed back. I finally got the copy of the lengthy blood test results, including tests new to me, and need them explained. Luckily, I was able to connect with a portal-less person, and did not take for granted the time she took with me to explain the tests and the results!!

After office or hospital procedures, the patient frequently receives by mail post-medical service questionnaires (I guess they don't want to use their own portal). Some of the questions ask the patient to evaluate the amount of dignity with which s/he has been treated. I can't wait to suggest on my next questionnaire that before the patient leaves the physician's office there is an offer to assist with setting up the portal, including instructions of how to access it. That would be helpful and keep ones dignity in intact.

Now, I turn to Physical Therapy, another medical matter, where in the background, there is usually some mindless talk show on the TV, complete with endless weather and traffic reports. As a group, we feel that we are more interesting than these bland, repetitive TV offerings. So my fellow PTers and I would like to pitch a TV show that would really resonate with our generation. To wit: picture the PT weatherman who dispenses with accuweather and instead reports what the weather will be based on how his back feels; the PT lie down comedy segment (not stand-up), as jokes are exchanged by prone patients during heat, ice and stim; the moving PT human interest stories full of dramatic moments and brave struggles toward recovery, of friend-ships forged, support offered and advice given. Now that's modern medicine.

to the aid of the right known as *tenure*. A suit filed in California challenging seniority and tenure rights was backed by a judge ruling that tenure has led to a concentration of incompetent teachers in impoverished areas and that teacher protection laws violated children's rights to a sound basic education. Spurred on to action in New York State, Campbell Brown (former news anchor) and the Partnership for Educational Justice (with its ties to Students First and Success Academy Charter School) backed a suit filed by seven parents in State Supreme Court on the same basis; however, it is interesting to note that whereas headlines and attention are focused on the tenure issue, discussion focuses upon the need for better qualified and better paid teachers, and help for the economy of impoverished areas and needy youngsters. California's Gov. Brown has already filed an Appeal.

"Tenure," we should all remember, simply means that a teacher is entitled to the fundamental right of due process and cannot be terminated without formal charges being presented. It is *earned* during the probationary period, as state law it is NOT negotiated by local unions. And it is most certainly NOT a cause of low student achievement.

Tundra's Journey

Although I have traveled to many places around the world, I recently completed one of the most quietly eventful trips I can remember. As is true for many retirees, I find my days (and some nights as well) to be near filled with things that I always wanted to get done, and can now do! Working for Volunteers for Wildlife as a rescuer, board member and program presenter has kept me very happily busy, never more so than when I was lucky enough to meet a snow- colored, yellow- eyed beauty from the far north --- a snowy owl!

As some of you may already know, it was a record year for snowy owl appearances in the United States. For reasons that are still not completely understood, the normally rarely seen owls were found in areas of the country, and in numbers in those areas, that have never been witnessed before. On a calm Sunday afternoon for example, I was called to JFK Airport to rescue a snowy that had been trapped in a power plant cooling tower. That rescue went wonderfully; I was able to release the owl at Jones Beach later in the week. However, the owl that I (and all of my coworkers) remember most is the one that was delivered to us by wildlife officials at LaGuardia. He had some injury caused by being sucked up in the back draft of a landing jet; a trip the next day

to one of our consulting veterinarians showed that injury to be a wing broken in at least two places. The owl, determined to be a young male, would spend at least the next several weeks with us at Volunteers, as we began his rehabilitation. The male snowy, soon named 'Tundra' by one of our board members, became an instant favorite among the staff. His recovery went well, but it became clear that although the wing would heal, it would never attain the strength needed to migrate back to the north, or hunt in the wild. As the weeks past and his vitality increased, we began the search for the best place for Tundra. We moved him to one of our outdoor aviaries so that he could flex that wing and move around. Although we limited access to his cage so that he would not be stressed out, we soon found that his favorite place was seated atop a perch were most visitors could see him, and he them. Some of the local newspapers ran stories on him; and a video of Tundra feeding on his daily quota of mice made him an instant celebrity. Although all of us at Volunteers wanted to keep him, Tundra needed to be in a cooler year-round climate, and at a facility that was equipped to care for him thoroughly. After weeks of looking, we decided on The Vermont Institute of Natural Sciences (VINS for short); a beautiful, well-staffed nature and education center located in Quechee, Vermont. Since I had been there many times before, I volunteered to drive Tundra; the trip was close to 300 miles and would take about five hours.

Tundra was a great passenger. He was well fed with a handful of fresh mice and relaxed in his typically quiet 'Buddha-like' fashion throughout the entire drive. At one stop, a pit stop for me, I took his carrier out of the car so that he could get some fresh air. A young woman, spotting the carrier and thinking that it contained a cat or dog, asked to see my 'pet'; she jumped back several feet when Tundra blinked his bright yellow eyes at her."Oh my God, he is absolutely beautiful", she said. I told her our story and moved on to Quechee.

When we arrived, most of the staff was there to greet us. We walked his carrier to a rehabilitation aviary and opened it up. Tundra jumped right out and stood there calmly looking at us. Both staff members exclaimed, "He is so calm!" It was very evident that our snowy owl had found a good home.

Wild creatures need their freedom; if they cannot be released they deserve to live out their lives in peace and safety; Tundra has both of those things, and more. In August, I went up to VINS to visit and the first aviary that I stopped at was Tundra's. He looked great; calm, confident and perched on the ground as usual. The staff love working with him; his relaxed nature has made the training needed to become a program bird progress ahead of schedule --- he will become a magnificent ambassador for his species, and for all wild things. I miss him, as do all of the staff at Volunteers, but he is in the best place that he can be; I wish him well.
